4. JURY OF THE FESTIVAL

The International Jury includes the representatives of music, dance and culture. The President of Jury (elected among the members of the Jury) is responsible for the work of Jury. 5. AWARDS

Awards - in the form of diplomas, gratitudes, trophies - are handed out during the Final Gala.

6. PARTICIPANTS OF THE COMPETITION

Children and youth under the age of 25 from Poland, Belarus, Ukraine, Lithuania, Russia and countries of the European Union.

7. AGE CATEGORIES AND NOMINATIONS:

The competition will be held in the following categories: groups, soloists and duets.

The competition will be held in the following nominations:

I nomination – choreography: classical dance, folk, sporty, ballroom dancing, oriental, modern dance, stage dance, children's dance etude

age category:

a) 6-10 y.o. b) 11-14 y.o. c) 15-18 y.o. d) 19-25 y.o.

One performance in each age category can last no longer than 6 minutes.

II nomination - vocal: operatic, folk, pop

age category:

a) 6-9 y.o. b) 10-12 y.o. c) 13-15 y.o. d) 16-18 y.o. e) 19-25 y.o.

One song in each age category can last no longer than 4 minutes.

III nomination - author's song

age category:

a) 12-15 y.o. b) 16-18 y.o. c) 19-25 y.o.

One song whose performer is the author of the text and music or a work written for the performer, for each age category not longer than 4 minutes.

IV nomination - instrumental performance

age category:

category for soloists:

a) 9-11 y.o. b) 12-14 y.o. c) 15-17 y.o. d) 18-25 y.o.

category for bands:

a) 9-11 y.o. b) 12-14 y.o. c) 15-17 y.o. d) 18-25 y.o.

category for orchestras:

a) mix

The organizer does not provide musical instruments and sound instruments.

Two tracks for each age category: soloists each no longer than 4 minutes, bands each up to 6 min, orchestras each up to 10 min.

V nomination - own music composition

age category:

a) 9-11 y.o. b) 12-14 y.o. c) 15-17 y.o. d) 18-25 y.o.

One song for each age category not longer than 4 minutes. on your own instrument without sound system, (accompaniment to be performed is also allowed)

VI nomination - circus art

age category:

a) up to 10 y.o. b) 11-13 y.o. c) 17-19 y.o. d) 20-25 y.o.

One song in for each age category not longer than 5 min.

VII nomination - artistic craft

age category:

a) 10-12 y.o. b) 13-15 y.o. c) 16-18 y.o. d) 19-25 y.o.

All areas of artistic craft, individual or group work, participant can submit one or more works to the competition, work dimensions without restrictions.

VIII nomination - ecological fashion

age category:

a) 10-12 y.o. b) 13-15 y.o. c) 16-18 y.o. d) 19-25 y.o.

The show of creations from ecological materials.

IX nomination - fashion theater "The Best Collection"

age category:

a) 10-12 y.o. b) 13-15 y.o. c) 16-18 y.o. d) 19-25 y.o.

Fashion show from the 5th upward collection.

X nomination - theater creativity

age category:

a) 7-10 y.o. b) 11-14 y.o. c) 15-18 y.o. d) 19-25 y.o.

One completed theatrical song with or without music, no more than 15 minutes.

8. SONG BACKGROUND AND MUSICAL INSTRUMENTS

The organizer provides music on the CD-Audio / USB.

The organizer does not provide musical instruments.

9. FESTIVAL STAGES

Depending on the number of participants, the organizer provides for conducting the Festival on the following scenes:

width 10.5 m, depth 7 m, height 7 m (auditorium hall UwB)

width 7.6 m, depth 5.7 m, height 3.7 m (Dom Ludowy in Supraśl)

10. PROGRAMME OF THE FESTIVAL

11. GALA AWARDS

All participants of the Festival and the audience are invited to the Gala Concert. Free admission. During the Final Gala, the results will be announced and the Festival participants recommended by the Jury will be announced. The organizer of the Festival will inform the recommended participants by phone about the invitation to perform at the Final Gala.
